Accordingly the Vice-Chancellor is pleased to order to restrict the use of single-use plastic bottle and encourage use of refillable bottles instead, ban on take-away coffee cup, lunch wrapped in disposable plastic packaging, plastic bags, disposable foodservice cups, plates and containers made in polystyrene foam, plastic straws, with immediate effect.

The universities, accordingly, are requested to undertake activities from the following indicative list during **World Environmental Day 2018 on 5th June**.


1. College/university level networking activities on mass awareness on disposal of plastic.


