NOTICE FOR POSTPONEMENT OF MOP-UP ROUND OF COUNSELLING-MBBS/BDS COURSES-2018

Pursuant to the directions conveyed by the Government of Himachal Pradesh (Department of Medical Education) vide letter No.HFW-B(E)3-38/2018 dated 24th August, 2018 and subsequent letter No. HFW(DME)H(III)G-301/10-Vol-IX dated 25th August, 2018 of the Director Medical Education & Research, H.P., the Mop-up Round of Counselling scheduled to be held on 27.08.2018 for filling up vacant seats of MBBS/BDS is hereby postponed till further directions from the State Government. However, the original application form alongwith requisite certificates/documents and Bank Draft of fee shall be deposited personally on the day of counselling at 10 AM in the office of the Assistant Registrar(Ent.Tests) H.P. University, Shimla-5 which will be notified in due course of time. Candidates who are already in the waiting list by virtue of second round of counselling are no need to apply afresh.
